- 1) Call to Order – 7:03 p.m. by April Cobb (president)
- 2) Coaches and Guest Comments – No coaches or guests were present
- 3) Athletic Director Update (April Cobb on behalf of Randy Cuthbert)
 - a) Winter updates
 - i) Weather and COVID have made scheduling a challenge. Teams will be playing a bunch of games in February because of postponements.
 - ii) Senior days will start the week of 08-Feb-2021. Senior parents will come to the gym for the ceremony but will not be allowed to stay for the game due to COVID restrictions. The Senior Parents will be allowed to watch from the gym lobby (Basketball/Cheer/Wrestling) or from the hallway above the pool (Swimming/Dive)
 - iii) OJR is streaming all winter home sporting events for the High School and Middle School.
 - b) Post-Season Games
 - i) At this time it does not appear that OJR will have any team champions for the winter.
 - ii) Both swim teams are undefeated, but there is no PAC for swimming this year because we can't complete a league schedule as half of the school don't have pools.
 - c) Other
 - i) Spring sports are scheduled to start 08-Mar-2021 for the High School and 22-Mar-2021 for the Middle School. Online registration is open until the end of Feb-2021 for spring sports.
